Description

The PATRIOT® Flame Fighter glove is suitable for use in direct firefighting (flashover, inside attack) as well as recovery, rescue and technical assistance within the meaning of DIN EN 659:2008 (DIN EN 659+A1+AC:2009). The glove insulates against heat and cold and is breathable. Heat-resistant up to 250 °C contact heat. The glove offers a high level of wearing comfort with particularly good grip and excellent protection against mechanical risks. Due to its Hipora insert the glove is breathable.
